TPCB, Inc. Welcomes New Executive Director and CEO, Jeffrey F. Paniati, P.E.

The [Transportation Professional Certification Board, Inc.](http://www.tpcb.org) (TPCB) Board of Directors appointed Jeffrey F. Paniati, P.E. as the new TPCB Executive Director and CEO in October 2015. The appointment followed Mr. Paniati joining the Institute of Transportation Engineers (ITE) staff as Executive Director and CEO. He steps into the two new positions taking over for Thomas W. Brahms, who retired from TPCB and ITE on December 31, 2015.

Prior to joining TPCB, Mr. Paniati had a 32-year career with the Federal Highway Administration, including serving as Executive Director from 2008-2015.



As Executive Director he was responsible for the day-to-day operations of the agency, overseeing 2,900 transportation professionals and a \$400 million operating budget. He assisted the FHWA Administrator on establishing programs, policies, and priorities for the \$40 billion annual federal-aid highway program. Under Mr. Paniati's leadership, FHWA was recognized as a Best Place to Work by the Partnership for Public Service. Previously, Mr. Paniati held senior leadership positions with FHWA in the areas of system management and operations, intelligent transportation systems, and highway safety.

Mr. Paniati has received numerous honor awards, including the prestigious Presidential Rank Award of Distinguished Executive. He has been inducted into the University of Connecticut Academy of Distinguished Engineers and the ITS America Hall of Fame. Mr. Paniati has a bachelor's degree in civil engineering from the University of Connecticut and a master's degree in civil engineering from the University of Maryland. He is a Fellow of ITE and a registered professional engineer.

The Public Director is NOT to be a transportation professional, but should be in a position to use the services of a certified transportation professional.

Certification Program Continues to Grow

Application and renewal rates continue to be strong for both the Professional Traffic Operations Engineer® (PTOE) and Professional Transportation Planner® (PTP) certification programs. With the applications received for the current February 2016 PTOE exam, there have been 4,030 applications to take the PTOE exam since the program began in 1999, and 562 applications to take the PTP exam. There are currently 3,025 PTOE certificants and 388 PTP certificants.

PTOE Certification Renewal Reminder

Renewal paperwork is now due for those who have received notification by email. The Transportation Professional Certification Board now states that those PTOE certificate holders who do not renew within three months of the expiration date will be required to retake the PTOE exam to become re-certified.
