Computer-based exams for PTOE, PTP, RSP1, and RSP2 may be taken during the following time frames :

June 1 to 30, 2020 - applications must be received by midnight, April 2, 2020

October 1 to 31, 2020 - applications must be received by midnight, July 23, 2020

February 1 to 28, 2021 - applications must be received by midnight Dec. 3, 2020

#### PTOE Profiles : Ben Ben Colucci Rios, Ph.D., P.E., PTOE (F) and Jeff Young, P.E. (M)

#### **PTOE Perspectives**

The first exam for the Professional Traffic Operations Engineer (PTOE) certification was administered in January 1999 by the Transportation Professional Certification Board. Twenty years later, the certification remains among the most prestigious in the industry. One ITE member shares his experience holding the certification, and another explains why his agency requires professionals submitting traffic studies have a PTOE.

**ITE JOURNAL:** Tell us a little more about your history of obtaining the PTOE certification.

**BEN COLUCCI RIOS:** After completing my Ph.D. at Purdue University in 1984, I started working as an assistant professor at the University of Puerto Rico at Mayagüez in transportation engineering. I also started writing proposals for the Highway and Transportation Authority in Puerto Rico and the U.S. Federal Highway Administration. I received an award to establish the Puerto Rico Transportation Technology Center (T2) - Puerto Rico LTAP (Local Technical Assistance Program). This center provides training and technical assistance to transportation professionals in Puerto Rico and the U.S. Virgin Islands in all areas associated with the planning, design, construction, operations, and maintenance of the built highway transportation infrastructure. In the late 1990s, I realized how critical it was to better prepare myself for the challenges the transportation engineers will face in the upcoming millennium. Eugene Wilson, P.E. (H) originally told me about the PTOE

**ITEJ:** Tell us a little more about your work at McHenry County. What are some of the day-to-day challenges you help solve and the types of projects you work on?

**JEFF YOUNG:** As the assistant county engineer at the McHenry County Division of Transportation (MCDOT), I oversee the administration, planning, design, and construction activities for the county. We have a great staff that makes my job a lot easier. There are always bumps in the road that come up unexpectedly, and it's key to address them immediately. This can range from an elected official who has questions about a construction project, a utility conflict with a roadway design that needs resolving by bringing the right people into the conversation, or a resident who has a concern about the safety at an intersection. We strive to solve problems using "small" solutions that can be implemented quickly.
